ORDER

On this day, came the Plaintiff, the West Virginia State Board of Registration for Professional Engineers ("Board"), by its counsel, N. Edward Eagloski, Board Counsel, and came, the Defendant, Robert E. Jones, individually, and d/b/a A Personal Services, a.k.a. A Personal Electrical, Plumbing, and Engineering, in person together with his counsel, Shawn D. Bayliss, Esquire, to inform the Court of the following:

1. That this action is for the entry of a permanent injunction against the Defendant, Robert E. Jones, from practicing engineering in the State of West Virginia.
2. That the Plaintiff is an agency of the State of West Virginia authorized by West Virginia Code § 30-13-1, et seq., to regulate the practice of engineering in the State of West Virginia.
3. The Board is situated in Charleston, Kanawha County, West Virginia.
4. That the Defendant, Robert E. Jones, is a resident of Kanawha County, West Virginia.
5. That this Court has jurisdiction over the subject matter and personal jurisdiction in this matter and that venue is proper.
6. That the Defendant, after consulting with his counsel, Shawn D. Bayliss, Esquire, consents to the entry of an order enjoining him permanently from practicing engineering in the State of West Virginia until such time that the Defendant may become properly licensed to do so by the Plaintiff.

7. The parties agree that no bond would be required to be posted by the Board as a condition precedent for the entry of this injunction.

Therefore, the Court, after Due and Mature consideration of the premises, does hereby **ORDER** the Defendant, Robert E. Jones, individually, and d/b/a A Personal Services, a.k.a. A Personal Electrical, Plumbing, and Engineering, be permanently enjoined from engaging in the practice of engineering in the State of West Virginia until such time as the Defendant may become properly licensed to do so by the Plaintiff.

The Court does hereby further **ORDER** the Defendant, Robert E. Jones, individually, and d/b/a A Personal Services, a.k.a. A Personal Electrical, Plumbing, and Engineering, be permanently enjoined from holding himself out as a person or entity practicing engineering in the State of West Virginia until such time as the Defendant may become properly licensed to do so by the Plaintiff.

The parties agree to bear their own costs and attorney's fees.


The Court **ORDERS** the Circuit Clerk to forward a certified copy of this Order to counsel of record.
